Clean the windshield and paste the electrostatic film


Avoid introducing air bubble. DO NOT paste the film repeatedly.

- Purchase the TF card from legal channel. To ensure safe and stable data transmission, it is recommended to use TF card of Class 10 or above.
- Format the new TF card first before using the card.

Make sure there is no metal around the device because metal will interfere with GPS signal. Make sure the location where the device is installed is not pastd with radiation protection film. The film will
